RULES & REGULATIONS

The EDFMA operating as The City Market Downtown on 104th and the City Market Downtown at City Hall offers a family friendly market, and we are pleased to provide a stage for the many diverse talents the City of Edmonton has to offer. We are pleased to offer Busking opportunities to APPROVED BUSKERS. All performers are required to apply and follow the process laid out below.

There is no cost for busking at the City Market Downtown, and you must be approved to perform at the market. In order to best showcase the excellent entertainment and ensure a profitable and good day for all Buskers, a rotation and a time limit are imperative. Buskers will be scheduled to take breaks and change locations during Saturdays. Three one hour sets will be the maximum playtime for all entertainment (performers 13 and older). The EDFMA Staff and its designates (Board of Directors) reserve the right to select the performers at the market, to maintain control of the program and the entertainment offered at its venues, and to dismiss a busker from the premises for songs, lyrics or behaviors deemed inappropriate for the audience or venue or atmosphere of the City Market Downtown on 104th or the City Market Downtown at City Hall.

Children 12 and under must be accompanied and supervised by an adult continuously, and will be allotted 1 set at 1 hour in length per day, program and space permitting. Children are exempt from the membership fee.

Buskers must be pre-screened, approved and scheduled, and are not permitted to begin performing without going through this process. Buskers are not approved on site. Applicants must have an application on file and will be contacted for an audition if required. Auditions may be in person or submitted on CD, DVD or via Youtube or other online site.
